# NOTICE OF RACE

## LAKE WINNIPESAUKEE SAILING ASSOCIATION

Saturday, September 16 & Sunday, September 17, 2000

**SITE:** Lake Winnepesaukee, New Hampshire. Race headquarters, launch, and haul out will be at Fay's Boat Yard in Gilford, NH. The Barbecue will be at the Winnepesaukee Yacht Club. Racing will be on the main portion of Lake Winnepesaukee, 1.5 miles East of Fay's Boat Yard.

**RULES:** This regatta will be governed by the 1997-2000 *Racing Rules of Sailing*, the prescriptions of US Sailing, the class rules of the respective classes, this notice, and by the Sailing Instructions.

**ELIGIBILITY:** Open to all J/24 and J/80 class yachts as defined by their class associations. Competitors must meet all ownership, class membership and yacht measurement requirements and must have paid all dues and event fees before becoming official competitors.

**ENTRY FEES:** The Entry Fee of \$60.00 includes Launching, Haul Out, Mooring, and Beer at Launching and Haul Out. There is an additional charge of \$7.00 if the owner or skipper is not a member of the US Sailing Association. In order for us to provide enough Beer and Food, we request that all entries be received **as early as possible**. For this reason, there is a late registration fee of \$10.00 if received after Monday, Sept 1, 2000.

**NOTE:** Early registration is requested. **The order of Haul Out on Sunday afternoon will be based on the order of registrations received.** Final registration will close at 0930 on Saturday at Fay's Boat Yard in Gilford, NH.

**RACING:** The racing on Saturday will include as many races as we can run for both classes. Sunday's racing will be planned so that all boats will be **out of the water** by 1730.

1000 to 1900 - Launching and Registration (Fay's Boat Yard)

**NOTE: No boats will be launched after 1900 on Friday evening.**

#### Saturday, September 17, 2000

0900 to 0930 - Final Registration (Fay's Boat Yard)

0930 - Skippers' Meeting (Fay's Boat Yard)

1100 - Warning Signal for first race (about 2 miles out)

1800 - Barbecue at Winnepesaukee Yacht Club

#### Sunday, September 18, 1998

1000 - Warning Signal for first race (about 2 miles out)

After Racing - Haul Out and Awards (note: Haul out will be in order of registrations received)

**Skipper's Meeting:** A Skipper's Meeting will be held at 0930 Saturday at Fay's to hand out registration packets and introduce the Race Committee.

**SCORING:** The Low Point Scoring System, as provided in Appendix A2 of the *Racing Rules of Sailing* will be used. A single race will constitute a regatta and all races will count.

**PRIZES:** Prizes will be awarded for first, second, and third for each class of boats. This will be the J/24 District #1 Championship.
